I hold all the instructions contained therein fully binding upon me, and in the light thereof I desire that after my death my body should be taken to Bahishti Maqbarah, Qadian for burial, provided permission is granted to me or, after my death, to my heirs by Majlis Karpardaz Masalih Qabaristan. If I fail to deposit in advance in the treasury of Sadr Anjuman Ahmadiyya Pakistan, Rabwah an adequate sun of money to cover expenditure to be incurred in transporting my remains, the same should be deducted from my estate. Such expenses will not be debited to the portion of my estate assigned by this Will to the Sadr Anjuman Ahmadiyya Pakistan, Rabwah, or by Tahrik-e-Iadid Anjuman Ahmadiyya Pakistan Rabwah, or by Tahrik-e-Iadid Anjuman Ahmadiyya Pakistan Rabwah, or by Cahrik-e-Iadid Anjuman Ahmadiyya Pakistan Rabwah, or the Majlis Karpardaz Masalih Qabaristan Qadian / Rabwah in connection with Bahishti Maqbarah or relating to Musi's, shall, to the extent that they relate to this Will, be binding on me and my heirs.
